SECTION 4 - FIRST AID MEASURES

General Information:

If irritation persists, repeat flushing and seek medical attention.

Eye Contact: Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 20 minutes or until the product is removed, while holding the eyelid(s) open. SECTION 5 - FIRE FIGHTING MEASURES
