SECTION 4 - FIRST AID MEASURES

General Information:

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. Potential Health Effects

Inhalation
