SECTION 4 - FIRST AID MEASURES

General Information:

Remove contaminated clothing, shoes and leather goods.(e.g. watchbands, belts). Flush contaminated area with lukewarm, gently flowing water for at least 20-30 minutes, by the clock. If irritation persists, continue flushing. DO NOT INTERRUPT FLUSHING. If necessary, keep emergency vehicle waiting (show paramedics this SDS and take their advice). Seek urgent medical attention. Eve Contact: Quickly and gently, blot or brush away chemical. Immediately flush the contaminated eye(s) with

lukewarm, gently flowing water for at least 20-30 minutes, by the clock, while holding the eyelid(s) open. Neutral saline solution may be used as soon as it is available. DO NOT INTERRUPT FLUSHING. SECTION 5 - FIRE FIGHTING MEASURES

Fire and Explosion Hazards: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. This product reacts with many metals liberating hydrogen gas which forms explosive mixtures with air. Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures. Extinguishing Media: Not Combustible. Use extinguishing media suited to burning materials. Water fog or fine spray is the preferred medium for large fires. SECTION 10 - STABILITY AND REACTIVITY

Reactivity: Inorganic acids react with inorganic and organic bases such as amines to form salts. They also react with many metals liberating hydrogen gas. These reactions are often rapid and typically liberate much heat. They can also decompose many organic materials such as esters, in a reaction called hydrolysis.
