**Physical Description & colour:** Clear blue liquid.

**Odour:** No odour.

**Potential Health Effects**

---

**Inhalation**

**Short term exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Long Term exposure:** No data for health effects associated with long term inhalation.

**Skin Contact:**

**Short term exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. In addition product is unlikely to cause any discomfort in normal use.

**Long Term exposure:** No data for health effects associated with long term skin exposure.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

**SECTION 4 - FIRST AID MEASURES**

**General Information:**

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

---

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill.
